The brand remains a frontrunner in its operating segment and is well positioned to sustain its leadership position in the industry. The Company commenced its commercial operations in July, 1995. II. Information about Mr. Samir

Mr. Samir (44), pursued his Post Graduate in Management and his Masters of Business Administration from the of Southern University Queensland. Australia. He completed his Diploma in Hotel Management from IHMCTAN, Ahmedabad in 1995. He brings with him rich and valuable operational & sales experience of 23 years, across India & abroad. He started his career with Holiday Inn Ahmedabad in May 1995 and worked with companies like Holiday Inn Gem Park, Ooty and Inter-Continental Marine Drive, Mumbai.

His last assignment was with Inter-Continental Hotels Group as Director of Operations Support, South East Asia and Korea, where he was responsible for driving operational performance, guiding mid-term strategy and setting up operational execution platforms across 58 hotels whilst managing revenue of USD 800 million.

Taking into consideration the size and financial position of the Company, the industry trend, the profile and experience of Mr. Samir, and the responsibility shouldered by him, the proposed remuneration of Mr. Samir, as stated above, is fair and reasonable in the opinion of the Board.

III. Other Information

The proposed remuneration of Mr. Samir exceeds 5% of the net profits of the Company for the financial year ended 31st March, 2020 and accordingly the profits of the Company are inadequate in terms of Schedule V to the Act.
